ARTICLE I--NAME

The name of this limited liability company is R. J. ENTERPRISE, L.L.C.

ARTICLE II--PURPOSE

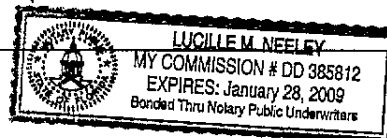
