Articles of Organization

of

Law Office of Frank P. DiPlacido, III, P.L.A Florida Professional Limited Liability Company

1. Name. The name of this limited liability company is Law Office of Frank P. DiPlacido, III, P.L. (the "Company"), and it shall be formed as a Florida professional limited liability company under Chapter 608, Florida Statutes and Chapter 621, Florida Statutes, to engage only in the practice of law.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the sole purpose of engaging in the practice of law; and, notwithstanding any other provision hereof, each member of the Company shall be licensed, authorized and in good standing to practice law in the State of Florida.

4. Place of Business. The mailing address and street address of the Company's principal office is 1620 Long Meadow Road, Fort Myers, Florida 33919.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Frank P. DiPlacido, III. The street address of the initial registered agent of the Company is 1620 Long Meadow Road, Fort Myers, Florida 33919.

6. Management of the Company. The Company shall be managed by a manager or managers and is, therefore, a manager-managed company. The initial sole manager of the Company is Frank P. DiPlacido, III.

7. Initial Member and Additional Members. The initial sole member of the Company is Frank P. DiPlacido, III. Except as otherwise provided in an Operating Agreement adopted for the Company, additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought; provided, however, that any additional member shall be licensed, authorized and in good standing to practice law in the State of Florida.

8. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal an Operating Agreement for the Company containing provisions for the regulation and management of the affairs of the Company.

9. Voting. The Company is authorized to issue membership units with voting rights and membership units without voting rights.

10. Certificated Interests. The members' interests in the Company may be evidenced by certificates.

11. Transfer of Interest. Except as otherwise provided in an Operating Agreement adopted for the Company, no member shall have the right to transfer any interest in the Company without the unanimous written agreement of all members. If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring member shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership. Notwithstanding any other provision hereof, any transferee must be licensed, authorized and in good standing to practice law in the State of Florida.

WHEREUPON, at Fort Myers, Florida, the undersigned, being the sole Member and Manager of the Company, has caused these Articles of Organization to be executed this 4th day of May, 2006.
