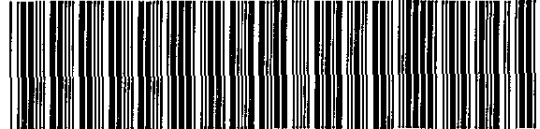

ARTICLE VI - Limitation on Agency Authority of Members:




