

# ARTICLES OF ORGANIZATION

#### ARTICLE I

#### NAME

The name of the limited liability company is KAREN FOR PEOPLE PLUS PETS, LLC (the "Company").

# ARTICLE II

#### ADDRESS

The mailing and street address of the Company's principal office is 16850 Jog Road, Suite 107, Delray Beach, Florida 33446; and

#### ARTICLE III

#### PURPOSE AND POWERS

Except as restricted by these Articles of Organization, this limited liability company is organized for the purpose of retail sales of pet accessories and dog grooming, and for each and every legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act.

Except as restricted by these Articles of Organization, this limited liability company shall have and may exercise all powers and rights which a limited liability company may exercise under Florida law or the laws of the United States of America.

#### ARTICLE IV

#### DURATION

The period of duration for the Company is perpetual.

#### ARTICLE V

# <u>MANAGEMENT</u>

#### ARTICLE VIII

### ADMISSION OF NEW MEMBERS

The initial member is the sole member of the Company. Additional members may be admitted only by the unanimous written consent of the existing member(s), and the existing member(s) shall determine the amount and nature of contributions by new members at the time the new members are admitted.

#### ARTICLE IX

#### CONTINUATION OF BUSINESS

The remaining members of the Company may not continue the business on the death, retirement, resignation, expulsion, bankruptcy of a member, or dissolution or the occurrence of any other event which terminates the continued membership of a member in the Company unless there is unanimous written consent by the remaining members to continue the business of the Company.

#### ADDITIONAL PROVISIONS

The power to adopt, alter, amend, or repeal any provision contained in these Articles of Organization or the Operating Agreement of the Company is vested entirely in the managing member listed above in Article VII herein, in accordance with the Florida Limited Liability Company Act.
