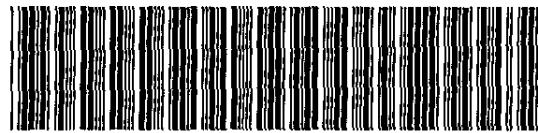

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I
NAME**

PURPOSE**


The purpose of the Company is to conduct all business permitted by law.


