**ARTICLES OF ORGANIZATION  
for  
CLAIMS YELLOW PAGES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be Claims Yellow Pages, LLC ("Company").

**ARTICLE II - STREET ADDRESS**

The street address of the principal office of the Company shall be 537 Deltona Boulevard, Suite 100, Deltona, Florida 32725.

**ARTICLE III - MAILING ADDRESS**

A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

**ARTICLE IX - INDEMNIFICATION**


The company shall indemnify its members, managers, officers, employees, and agents to the full extent permitted by law.


