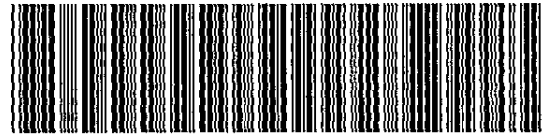

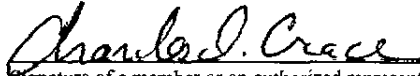
ARTILCE VIII-AMENDMENT
