ARTICLES OF ORGANIZATION CRETARY OF STATE TALLAHASSEE, FLORIDA BARSA DEVELOPMENT

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

ARTICLE I - NAME

The name of the Company is BARSA DEVELOPMENT, LLC.

ARTICLE II - DURATION

The duration of the Company is perpetual.

ARTICLE III - ADDRESS AND PLACE OF BUSINESS

<u>ARTICLE IV - PURPOSE</u>
