

ARTICLES OF ORGANIZATION OF MAVENCAMP, LLC

The undersigned hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

Mavencamp, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

4401 Dylan Loop, #169 Land O'Lakes, Florida 34639

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 4401 Dylan Loop, #169, Land O'Lakes, Florida, 34639, and the initial registered agent of the Company at such office shall be J. Mathew Mavencamp. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE V

Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the members of the Company. The Operating Agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the

Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
