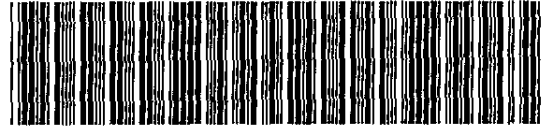

NAME & ADDRESS OF PRINCIPAL PLACE OF BUSINESS**



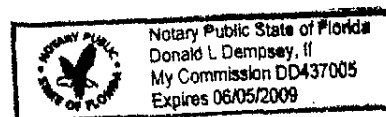
