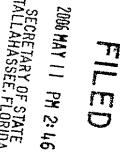

## ARTICLES OF ORGANIZATION FOR JHDR HOLDINGS, LLC A FLORIDA LIMITED LIABILITY COMPANY FILED PURSUANT TO FLORIDA STATUTE §608.407



#### ARTICLE I

The name of the Company is JHDR HOLDINGS, LLC.

#### ARTICLE II
