### ARTICLES OF ORGANIZATION OF

#### A KHAN TELECOM LLC

THE PROPERTY OF THE PARTY OF TH The undersigned, for the purpose of forming a limited liability company use the Florida Limited Liability Company Act, Florida Statutes Chapter 608, here makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**
