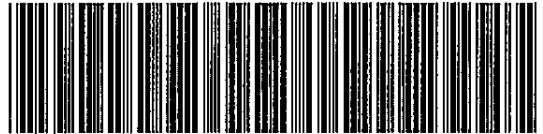



of






