ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
OF  
JERECO-ST. PETERSBURG, LLC

The undersigned being the sole Member of Jereco-St Petersburg, LLC, a Florida limited liability company (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is Jereco-St. Petersburg, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State on May 11, 2006. Articles of Amendment to the Articles of Organization were filed with the Florida Department of State on December 22, 2014.
3. Article V of the Company's Articles of Organization, is deleted in its entirety and the following is substituted therefore:

"ARTICLE V

The Limited Liability Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The authority and duties of the Manager(s) shall be as set forth in the Operating Agreement of the Limited Liability Company. The name and address of the Manager is James K. Petrillo, 235 Third Street, Suite 200, St. Petersburg, Florida 33701.

4. These Articles of Amendment to Articles of Organization shall be effective upon filing with the Florida Department of State.
5. These Articles of Amendment have been approved by unanimous Written Action of the Member dated May 1, 2017, which vote is sufficient for approval.
6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization, as amended, shall remain in full force and effect and are hereby ratified and confirmed.


