ARTICLE 3 - EFFECTIVE DATE


These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be hertinvalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be otherwise affected.
