

# ARTICLES OF ORGANIZATION of LOT 38 ARMOR FORD, L.L.C.

The undersigned, being a duly authorized person, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

#### ARTICLE I

#### ARTICLE II NAME AND PRINCIPAL PLACE OF BUSINESS
