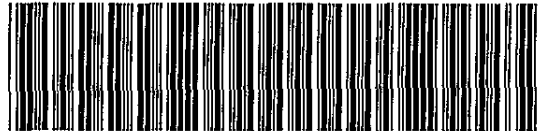

**ARTICLES OF ORGANIZATION  
OF

1. Name. The name of the limited liability Company (hereinafter referred to as "Company") is: LIONSHEAD DEVELOPMENT, L.L.C.

4. Additional Members. The members may admit such additional members upon consent of a majority of the members and only after agreeing to be bound by the provisions of the Operating Agreement.

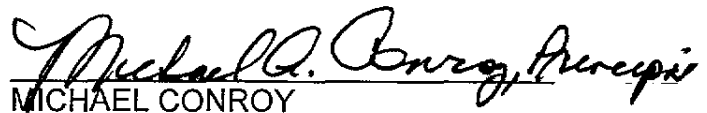

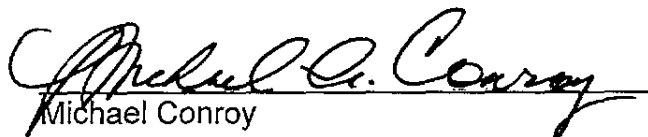
