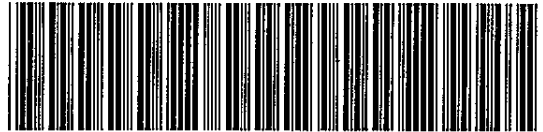



The name of the professional limited liability company is Top Hat Development, LLC


### ARTICLE II –ADDRESS
