**ARTICLES OF ORGANIZATION
OF
GLOBAL INVESTORS, LLC**

**ARTICLE I
NAME & ADDRESS OF PRINCIPAL PLACE OF BUSINESS**

The name of this Limited Liability Company (LLC) is **Global Investors, LLC**. The mailing address is P.O. Box 3204 Jacksonville, Florida 32206 and street address of the principal place of business for this LLC is 4020 Pearl Street, Jacksonville, Florida 32206.

**ARTICLE II
NATURE OF BUSINESS**

The Global Investors, LLC is organized for the purpose of and engaging in any or all lawful activities concerning the purchase, sale, lease, or rental of real property, both commercial and residential as permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation. To render service, manufacture, purchase, or otherwise acquire, and mortgage, pledge, sell, assign, transfer or otherwise dispose goods, real and personal property; all of the foregoing in this article shall be construed as both objects and powers of the subject LLC. The enumeration of powers and purposes is not intended to restrict or limit in any way the powers or purposes of this LLC.

**ARTICLE III
MANAGEMENT & DISTRIBUTIONS OF THE LLC**

Global Investors, LLC shall be manager-managed limited liability company. Decisions concerning the business and affairs of the LLC shall be made by the managing members :

Khaleelah Jones, 2616 Flander St., Jacksonville, FL 32206.

Except as otherwise determined by the Member(s):

- a) Only the Member shall be entitled to allocations of LLC profits and losses, to allocations of distribution of LLC profits and other LLC assets and to distributions of LLC profits and other assets; and
- b) No other person shall have any right to any such allocations or distributions.
- c) It shall be within the sole and exclusive discretion of the Member to determine the

timing and amount of allocations of the LLC's profits, losses and other assets to the Member- provided that the LLC shall make no such distribution to the extent that, immediately after the distribution, the LLC's liabilities would exceed its assets.

**ARTICLE IV
TERM OF EXISTENCE**

The LLC shall be dissolved when its last remaining member is disassociated.

**ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this LLC in the State of Florida is 4321 Roosevelt Boulevard, Jacksonville, Florida 32210 and the name of the initial registered agent of this corporation at that address is Donald L. Dempsey, II, Esquire. The managing-member may, from time to time, change the registered agent or move the registered office to any other address in Florida.

These Articles of Organization may be amended in the manner provided by law for the State of Florida.

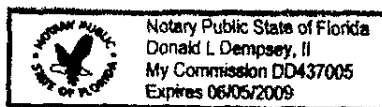

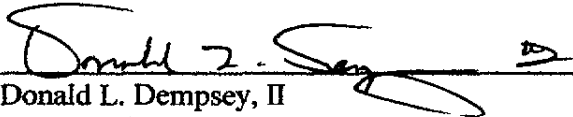
