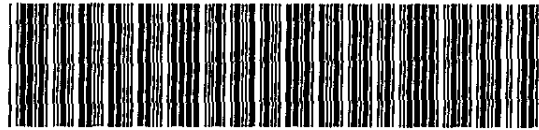



KNOW ALL MEN BY THESE PRESENTS: That I, **Kenneth R. Hayes, Jr.**, desiring to form a Florida Limited Liability Company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, adopts the following Articles of Organization, pursuant to section 608.407, Florida Statutes:

ARTICLE I

Company Name:

That additional Members will be admitted or expelled only with the unanimous consent of all Members entitled to participate in management and upon such terms as are unanimously agreed to by all Members entitled to a dividend upon dissolution or liquidation.

ARTICLE IX

Existence:


That the remaining Members of the limited liability company may only have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which terminates the continued Membership of a Member in this limited liability company if they unanimously elect to do so. The return of capital and the distribution of profits shall be determined from the company's books, as of the effective date of withdrawal, based on generally accepted accounting practices, and paid as soon as practicable without diminishing the prospects of the company's ventures and subject to the limitations of the Florida Limited Liability Company Act.

ARTICLE X

Management:

The business of the company shall be conducted under the exclusive management of its Members, or outside managers if its Members unanimously elect, who shall have exclusive authority to act for the company in all matters. The Members may from time to time designate certain Members as Officers to act for the Company in certain matters as specified by the Operating Agreement.
