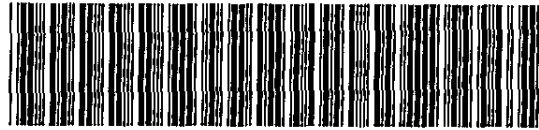

ARTICLE I. COMPANY NAME




