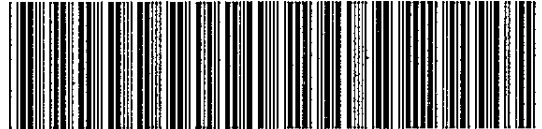





ARTICLE V – MANAGING MEMBER(S)

The Limited Liability Company is to be managed by the member(s) who are designated, appointed, or elected to act as managing member(s) in accordance with the Operating Agreement of the Limited Liability Company. ARTICLE VI - MEMBERSHIP

With written consent of the simple majority of the members, new members may be admitted into the limited liability company upon the payment of such capital contribution and upon such terms as the members decide by simple majority vote. In the event that new members are admitted into the limited liability company, the share of each new member in the profit and losses shall be such proportions as may be agreed upon between all the members and the new members.

ARTICLE VII – MANAGER’S LIABILITY
