**ARTICLE III**



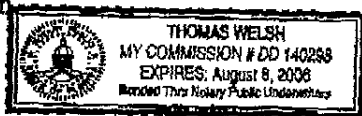
