

ARTICLES OF ORGANIZATION FOR SWANSON AVIATION, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be SWANSON AVIATION, LLC ("the Company").
