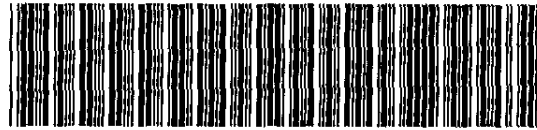

**ARTICLES OF ORGANIZATION
FOR


ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS
