The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608 (the "Act"), hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be APSNAT, LLC, (hereinafter referred to as the "Company").

ARTICLE II - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The Company's existence shall be perpetual, unless the company is dissolved earlier as provided by law or in these Articles of Organization or in the Operating Agreement.

ARTICLE III - PURPOSE

The purpose for which the Company is organized is to engage in all lawful business and activities as permitted by the Act. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

ARTICLE IV - ADDRESS

The mailing address of the principal office of the company is 10119 Shortwood Lane, Orlando, Florida 32836. The address may be changed from time to time as provided in the Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT

The name and street address of the Registered Agent of the company in the State of Florida is JEFFERY D. WILSON, 10119 Shortwood Lane, Orlando, Florida 32836.

ARTICLE VI - CAPITAL CONTRIBUTIONS

The member or members of the company shall contribute to the capital of the company either cash or properties as they may from time to time in their discretion determine or as otherwise set forth in the Operating Agreement.

ARTICLE VII - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members if more than one member.

ARTICLE VIII - ADMISSION OF NEW MEMBERS

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then existing members, or as otherwise provided in the Operating Agreement.

ARTICLE IX – MANAGEMENT

The company shall be managed by the members in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the company. The Operating Agreement may contain provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization. JEFFERY D. WILSON has full authority to execute the Articles of Organization and other documents necessary for the operation and management of the Company until otherwise designated or changed in the Operating Agreement. Any and all action by the Company shall require the vote of members holding a majority interest in the Company.

ARTICLE X - INITIAL MEMBERS

The Company shall have two members initially. The number of members can be increased or diminished from time to time by the Operating Agreement, but shall never be less than one member. The names and addresses of the initial members of the company are:
