**ARTICLES OF ORGANIZATION
OF
Starlight Shipping, LLC
A Florida Limited Liability Company**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE 1 – Name: Starlight Shipping, LLC (the “Company”).

ARTICLE 2 – Address: The mailing address and street address of the principal office of the Company is: 3389 Sheridan Street, #563, Hollywood, Florida 33021.

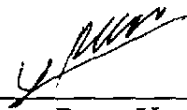

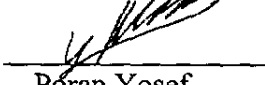
