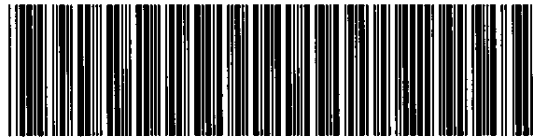

**ARTICLES OF ORGANIZATION OF
EMS OF DELAND, LLC**

Article I

The name of the limited liability company ("Company") is EMS OF DELAND, LLC.

Article II

The mailing address of the Company is P.O. Box 459, DeLand, FL 32721-0459 and street address of the Company's principal office is 223 S. Woodland Blvd., DeLand, FL 32720. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.

Article IV

The name of the Company's initial registered agent in Florida is Kirk T. Bauer. The address of the Company's registered office in Florida is 223 S. Woodland Boulevard, DeLand, Florida 32724.

Article V

The management of the Company shall be vested pursuant to the Operating Agreement in the manager(s), who shall be appointed by the members and who shall have the exclusive right to control and manage the Company. The initial managers of the Company are: James B. Clayton and Nancy P. Clayton, P.O. Box 39, DeLeon Springs, FL 32130.

Article VI

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted. The initial members of the Company are: James B. Clayton and Nancy P. Clayton, P.O. Box 39, DeLeon Springs, FL 32130.

Article VII

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company as provided in the Company's Operating Agreement.

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company is vested entirely in the Members and any such adoption, alteration, amendment or repeal must be done by unanimous written consent of the Members.


