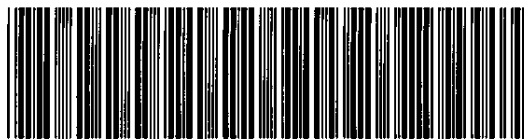

ARTICLE V


