**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF

Pursuant to Section 608.411, Florida Statutes, **FLORIDA VP LAKE LAND, LLC**, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

- FIRST:** The Articles of Organization were filed on May 17, 2006, and assigned document number L06000051370.
- SECOND:** Article I of said Articles of Organization is amended in its entirety to change the name of the Company from "**FLORIDA VP LAKE LAND, LLC**" to "**LIBERTY VP LAKE LAND, LLC**", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

"ARTICLE I - NAME

The name of this limited liability company is **LIBERTY VP LAKE LAND, LLC** (the "Company")."

- THIRD:** All other provisions of the Articles of Organization remain unchanged and in full force and effect.
- FOURTH:** The foregoing amendment was adopted by the sole Member of the Company on July 19th, 2006..
