ARTICLES OF ORGANIZATION

OF

ECV DEVELOPMENT, LLC

Pursuant to the provisions of Sections 608.401, et seq. of the Florida Limited Liability Company Act, as smended (the "Act"), the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is ECV Development, LLC (the "Company").

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The principal office of the Company shall be located at:

514 Scabrecze Circle Panama City Beach, Florida 32413

and its mailing address is the same.

ARTICLE III REGISTERED OFFICE: REGISTERED AGENT

The location and street address of the initial registered office of the Company shall be 514 Seabreeze Circle, Panama City Beach, Florida, 32413 and its registered agent at such address shall be Stewart R. Dudley.

ARTICLE IV MANAGERS

The Company is to be managed by one (1) or more Managers in accordance with the provisions set forth in the Operating Agreement of the Company. The name and address of the initial Manager of the Company, who shall serve until his successor is elected and shall begin serving, is:

ARTICLE V DURATION

The Company shall have perpetual duration unless it is dissolved and its affairs wound up in accordance with the Act or the Operating Agreement of the Company.

ARTICLE VI PURPOSES

The purposes for which the Company is formed are as follows:

- (i) To acquire, develop, improve, manage, lease and sell real property either directly or indirectly through one or more entities in which Company participates as a partner, shareholder, member, manager, contractor or agent;
- (ii) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;
- (iii) To lend money, invest and reinvest its funds and take and hold real and personal property as security for the payment of fluds so loaned or invested; and
- (iv) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

ARTICLE VII DISSOLUTION BY REASON OF CESSATION OF MEMBERSHIP

The cessation of membership of one (1) or more Members of the Company will not result in the dissolution of the Company unless required under the Act upon the cessation of the last remaining Member.

ARTICLE VIII REGULATION OF INTERNAL AFFAIRS

The provisions for the regulation of the internal affairs of the Company are set forth in the Operating Agreement of the Company, as the same may be amended from time to time in accordance with its terms.
