

ARTICLES OF ORGANIZATION FOR

BOCA VISTA RV RESORT, LLC

A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE I - Name

The name of the limited liability company is BOCA VISTA RV RESORT, LLC

ARTICLE II - Address

ARTICLE V - Admission of Additional Members

ARTICLE VI - Members' Rights to Continue Business

The remaining members of the limited liability company shall have the right to continue the business of the limited liability company on the death, bankruptcy or dissolution of a member or the occurrence of any other event as specified in the regulations of the limited liability company which results in the disassociation of a member from the limited liability company, upon the written consent of not less than seventy five percent (75%) of the Percentage Interests (as defined in the regulations of the Company) of such remaining members to continue the business of the limited liability company.
