AMENDMENT TO ARTICLES OF ORGANIZATION FOR MIL-KIN PROPERTIES, LLC

The Articles of Organization for MIL-KIN PROPERTIES, LLC, a Florida Limited Liability Company, are hereby amended to add Article VI thereto as follows:

ARTICLE 6

Admission of additional Members and Withdrawal from the Company by Members:

Additional Members may be admitted to this limited liability company only upon such terms as are unanimously agreed to by all Members. A Member may withdraw from this company upon a written request to withdraw and acceptance of that withdrawal by all Members. The withdrawal and resignation by a Member from this limited liability company prior to dissolution and winding up of the limited liability company will not cause this limited liability company to be dissolved. Upon withdrawal a withdrawing Member is entitled to receive any distribution to which the withdrawing Member is entitled consisting of the fair value of the withdrawing Member's interest in the limited liability company as of the date of resignation and upon the withdrawing Member's right to share in distributions from the limited liability company. A withdrawing Member may demand and receive only cash in return for the Member's contribution to capital.
