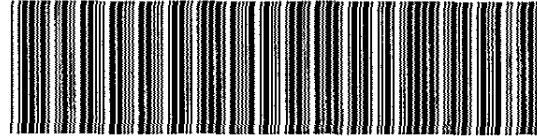

Amendment to Articles of Organization of DGAK, LLC

This Amendment to the Articles of Organization of DGAK, LLC is made this 13th day of July, 2006, by DGAK, LLC, a Florida limited liability company (the "Company"), Derek Goetz ("Goetz"), and Aleksandr Kruchakov ("Kruchakov").

Whereas, the parties filed the Articles of Organization (the "Articles") of the Company with the Florida Department of State on May 18, 2006, and

Whereas, the Goetz and Kruchakov constitute all the members and managers of the Company, and have the authority to execute this Amendment; and

Whereas, the Articles inadvertently stated that the Goetz and Kruchakov are "members," but should have stated that both Goetz and Kruchakov are "manager/members;"

Whereas, the parties desire amend the Articles accordingly;

Now, therefore, the parties agree to amend the Articles as follows:

1. The Articles of Organization are hereby amended to provide that Goetz and Kruchakov are both "manager/members."
2. The Florida Department of State is hereby authorized and requested to change the designation of both Goetz and Kruchakov on the Department of State website from "member" to "manager/member."
3. All other terms and conditions of the Articles shall remain in full force and effect, except as specifically provided herein.
