

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY



The undersigned authorized representative, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

ARTICLE I - Name

The name of the limited liability company created hereby ("the Company") is: Beatle, LLC

ARTICLE II - Purpose

The Company's purpose shall be to engage in any lawful business activity. The Company shall have the same powers as an individual to do all things necessary to carry out its business and affairs, including, without limitation, all powers permitted by the Florida Limited Liability Company Act.

ARTICLE III - Address

The mailing address and street address of the principal office of the Company shall both be:

ARTICLE IV - Duration

The existence of the Company shall commence on May 18, 2006 and shall thereafter be perpetual, unless dissolution or conversion occurs according to law.

ARTICLE V - Management

ARTICLE VI - Membership Units

The total number of membership units authorized to be issued by the Company shall be 10,000 maits. Each of the said units shall entitle the holder thereof to one (1) vote at any meeting of the members. All or any part of said units may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the Managers of the Company at a meeting called for such purposes. All membership units then issued shall be paid for and shall be nonassessable.

ARTICLE VII - Ownership

The initial members of the Company and their ownership interest therein shall be as set forth in the Operating Agreement of the Company.

ARTICLE VIII - Admission of Additional Members

Additional members may be admitted to the Company in accordance with the terms and provisions of the Operating Agreement of the Company.

ARTICLE IX - Registered Office and Agent

The address of the initial registered office of the Company in the State of Florida is 432 Korbus Rd., Brooksville, Florida 34604, and the name of the registered agent at such address is Robert Betlewicz.
