ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

The undersigned authorized representative, desiring to form a limited liability company? pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company created hereby (the "Company") is: J & S MANAGEMENT SERVICES, LLC

ARTICLE II - PURPOSE

The Company's purpose shall be to engage in any lawful business activity. The Company shall have the same powers as an individual to do all things necessary to carry out its business and affairs, including, without limitation, all powers permitted by the Florida Limited Liability Company Act, and the power to:

(a) Sue and be sued, and defend, in its name.

(b) Purchase, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal with real or personal property, or any legal or equitable interest in property, wherever located.

(c) Sell, convey, mortgage, grant a security interest in, lease, exchange, and otherwise encumber or dispose of, all or any part of its property.

(d) Purchase, receive, subscribe for, or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, grant a security interest in, or otherwise dispose of and deal in and with, shares or other interests in or obligations of any other entity.

(c) Make contracts or guarantees, or incur liabilities; borrow money; issue its notes, bonds, or other obligations, which may be convertible into or include the option to purchase other securities of the Company; or make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting limited liability company; a corporation which owns, directly or indirectly, a majority of the outstanding membership interests of the contracting limited liability company; or a corporation the majority of the stock of which is owned, directly or indirectly, by a corporation which owns, directly or indirectly, the majority of the outstanding membership interests of the contracting limited liability company, which contracts of guaranty and suretyship shall be deemed to be necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company; or make other contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company; or make other contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company;

Lend money, invest or reinvest its funds, and receive and hold real or personal £) property as security for repayment.

Conduct its business, locate offices, and exercise the powers granted by Florida (g) Statutes Chapter 608 within or without the State of Florida.

(h) Select managers and appoint officers, directors, employees, and agents of the Company, define their duties, fix their compensation, and lend them money and credit.

Make donations for the public welfare or for charitable, scientific, or educational (i) purposes.

Pay pensions and establish pension plans, pension trusts, profit-sharing plans, (i)retirement plans, bonus plans, option plans, and benefit or incentive plans for any or all of its current or former managers, members, officers, agents, and employees.

Be a promoter, incorporator, shareholder, partner, member, associate, or manager of (k)any corporation, partnership, joint venture, trust, or other entity.

Make payments or donations or do any other act not inconsistent with law that (f) furthers the business of the Company. 06 MAY 18

ARTICLE III - ADDRESSES

The mailing and physical address of the principal office of the Company shall be:

ARTICLE IV - DURATION

The existence of the Company shall commence on May 15, 2006, and shall thereafter be perpetual, unless dissolution or conversion occurs according to law.

ARTICLE V-MANAGEMENT

The Company shall be managed by one or more managers.

ARTICLE VI - MEMBERSHIP UNITS

The total number of membership units authorized to be issued by the Company shall be 10,000 units \$.01 par value. Each of the said units shall entitle the holder thereof to one (1) vote at any meeting of the members. All or any part of said units may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the Manager or Managers of the Company at a meeting called for such purposes. All membership units then issued shall be paid for and shall be nonassessable. The Company elects to have preemptive rights.

The initial members of the Company and their ownership interest therein shall be as set forth in the Operating Agreement of the Company.

ARTICLE VIII - ADMISSION OF ADDITIONAL MEMBERS

Additional members may be admitted to the Company in accordance with the terms and provisions of the Operating Agreement of the Company.

ARTICLE IX - REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Company in the State of Florida is 315 S. Hyde Park Avenue, Tampa, Florida 33606, and the name of the registered agent at such address is James P. Hines.
