# ARTICLES OF ORGANIZATION OF 320 BELLA COLLINA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be 320 Bella Collina, LLC, (the "Company").

#### ARTICLE II -- ADDRESS

The mailing and street address of the initial principal office of the Company shall be 6504 Caprezzo Way, Elk Grove, CA 95757.

#### ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filled by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's operating agreement (the "Operating Agreement").

## ARTICLE IV -- REGISTERED OFFICE AND AGENT

## ARTICLE V -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous prior written consent of all members and on such terms and conditions as shall be approved by unanimous consent of all members. A member may transfer their interest in the Company only as set forth in the Operating Agreement of the Company.

## ARTICLE VI – TERMINATION OF EXISTENCE

The Company shall be dissolved upon the occurrence of events specified in the Company's Operating Agreement.

## ARTICLE VII - WITHDRAWAL OF MEMBERS

A Member of the Company may withdraw from the Company upon the unanimous prior consent of all of the non-withdrawing members of the Company.

### ARTICLE VIII -- MANAGEMENT

The Company shall be managed by the members in accordance with the Operating Agreement adopted by the Members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization.
