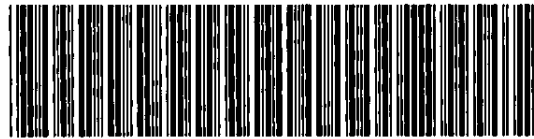

ARTICLE 1 - NAME

The name of the limited liability company shall be **LA' IGUANA SPORTS BAR & NITE CLUB LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 4645 Gun Club Road, West Palm Beach, Florida 33413 and the mailing address shall be 8175 Belvedere Road, Apartment #102, West Palm Beach, Florida 33411.

ARTICLE 3 - EFFECTIVE DATE

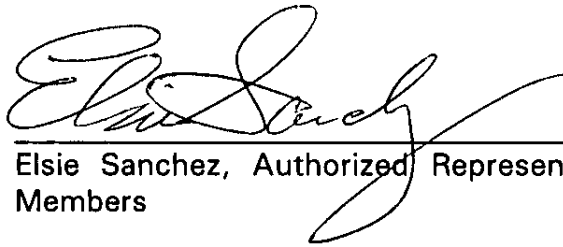

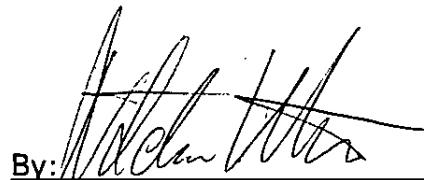
