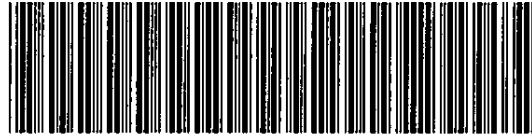



**ARTICLE I
Name**


**Article V
