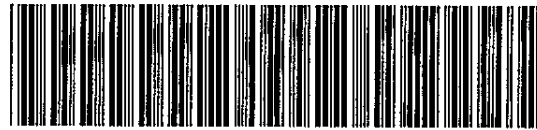

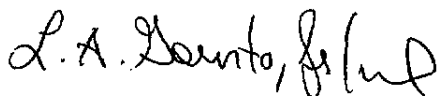

NAME

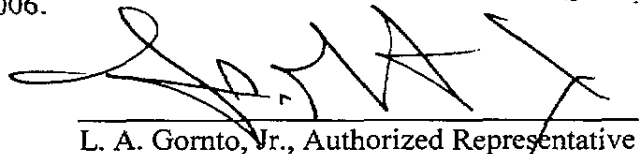

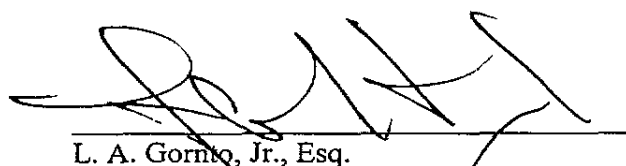
