ARTICLES OF ORGANIZATION

OF

Jazannah, L.L.C.

The undersigned person, seeking to form a limited liability company under the Florida Statutes, Chapter 608, hereby executes the following Articles of Organization.

- I NAME. The name of the limited liability company shall be: Jazannah, L.L.C. ("Company").
- II ADDRESS. The initial mailing address and street address of the principal office of the Company shall be 10312 NW 13th Lane, Gainesville, Florida 32606.
- III DURATION. The Company shall commence upon filing of these Articles of Organization with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization.
- IV REGISTERED OFFICE AND AGENT. The name of the initial registered agent of the Company in the State of Florida is Christopher S. Coleman and the street address of the registered office of the Company is 10312 NW 13th Lane, Gainesville, Florida 32606.
- V CAPITAL CONTRIBUTIONS. The members of the Company will contribute to the capital of the Company in cash or property. Each member may make additional capital contributions to the Company upon the unanimous consent of all the members.
- VI ADMISSION OF NEW MEMBERS. No additional members shall be admitted to the Company without the written consent of all the members of the Company and fipon such terms and conditions as shall be determined by all the members. - VIII MANAGEMENT. The Company shall be a manager-managed company in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
