ARTICLES OF ORGANIZATION

OF

ARTICLE I

Name. The name of the limited liability company ("Company") is LIVOS TECHNOLOGIES, L.L.C.

ARTICLE II

Nature of Company: The general nature of the business to be transacted by the Company under these Articles of Organization shall be to engage in the development, manufacturing and sale of marine products and to engage in any other activity or business permitted under the laws of the United States and of the State of Florida and to carry out said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

These Articles of Organization shall be emended as follows: every proposed amendment to these Articles of Organization shall require the approval by the Managing Member, whereupon it shall be proposed to all the Members, and, for adoption, shall require the approval at a Member's meeting by a majority of the members entitled to vote thereon; alternatively, a majority of the Members may sign a written statement adopting the proposed Amendment to these Articles of Organization.

ARTICLE X

Operating Agreement. The Operating Agreement of the Company shall be made, altered or rescinded by a majority vote of the Members of the Company at a meeting of the Members; alternatively, all of the Members may sign a written statement adopting the proposed Operating Agreement or changes thereto.
