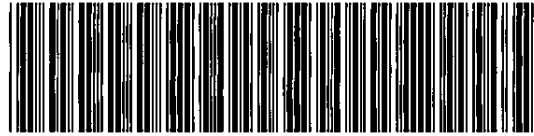

**ARTICLE X  
PROPERTY**

(c) Conveyances.
