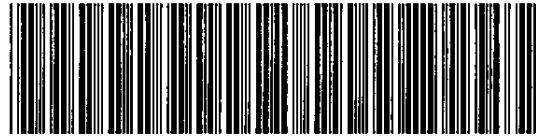



ARTICLES OF ORGANIZATION
OF
MANATEE REVITALIZATION GROUP, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **MANATEE REVITALIZATION GROUP, L.L.C.**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 5411 8th Avenue West, Bradenton, Florida 34209.

ARTICLE III - DURATION

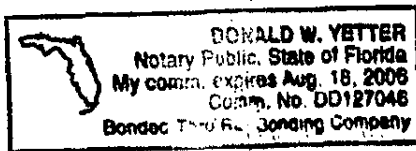
