ARTICLES OF ORGANIZATION

OF

SUN COAST SITE SERVICES, LLC

The undersigned persons, acting as the organizers of SUN COAST SITE SERVICES, LLC (the "Company") under the Florida Limited Liability Company Act, Chapter 608, <u>Florida Statutes</u>, adopt the following Articles of Organization:

ARTICLE I. NAME AND ADDRESS
