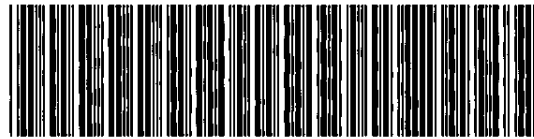

NAME**

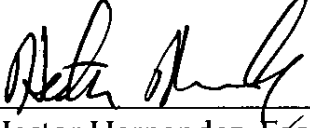

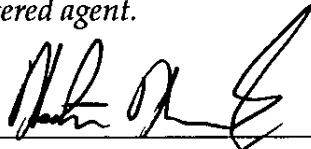
