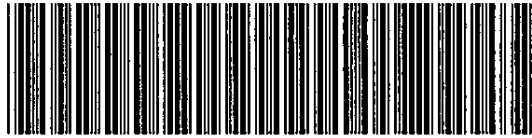




The undersigned, constituting all of the Members and the Managing Member of Prime Kosher 18, LLC, do hereby amend the Articles of Organization, as follows:

Except as modified hereby, the parties do hereby ratify and confirm the Articles of Organization.


