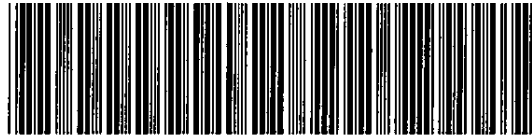

**ARTICLE I – Name:**

The name of the Limited Liability Company is: **VACATION RENTAL PROS, LLC.**

**ARTICLE II – Address:**

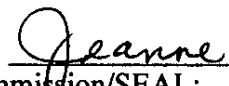

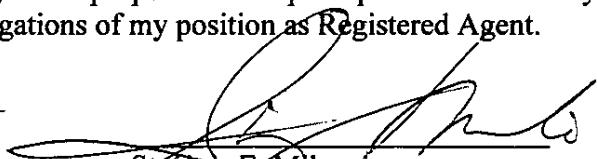
