ARTICLES OF ORGANIZATION

OF

STEVENSON DEVELOPMENT COMPANY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The mailing address and street address of the principal office of the Company shall be 3742 Seagrape Street, Big Pine Key, FL 33043.

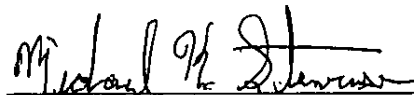
ARTICLE IV – MANAGING MEMBER

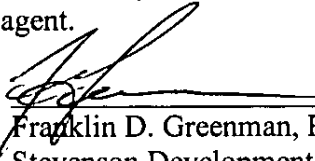
