# ARTICLES OF ORGANIZATION OF

# NIM GLOBAL, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability Company shall be NIM Global, LLC ("Company").

#### ARTICLE V -- ADMISSION OF NEW MEMBERS
